Glendo Preschool In Jeopardy

In 2020, Glendo Schools created a pre-kindergarten program. Over 20 children have benefited from the program. Pre-kindergarten is not funded by the State of Wyoming, through the years, a variety of sources have been utilized to pay for the program. A vital grant is no longer available for the school year 2025-2026, leaving a funding shortfall of up to \$60,000 for the program.

The U.S. Department of Health and Human Services reports, "From the ages of birth to 5, children's brains are developing rapidly and their capacity for learning is unparalleled. In these formative years, children are laying the cognitive and behavioral foundation for the rest of their development and learning." K-2 teacher, Brooke Eller said, "Preschool has been beneficial to those kindergartners who come in not necessarily academic wise... just knowing how to follow a routine, a direction, and come in and have some social skills and to regulate themselves. That's huge."

Stakeholders have teamed up with Keep Glendo Great to secure funding, Keep Glendo Great has applied for \$30,000 worth of grants, the actual funding shortfall is unknown, however, possible excess donations will be used to fund the program for future years. Local donations can be made to Keep Glendo Great P.O. Box 66, Glendo WY 82213. Keep Glendo Great is 501 c.3 and all donations are tax deductible.

Court Date Set for Ex-Town Clerk

A court date has been set for Glendo's ex-town clerk, Tristany Hoffman. The jury trial is July 7, 2025, at 9:30 a.m. Hoffman is being charged with three separate alleged counts of felony theft between May and July 2024. According to court documents, all motions, notices, requests and demands must be filed by April 21, 2025. The Plea Cut Off Date is May 29, 2025. If a plea deal is struck, a change of plea hearing will be held at the time originally scheduled for the Pretrial Conference. The Pretrial Conference is June 5, 2025 at 10:00 a.m.. Anyone charged with a crime is presumed innocent until proven guilty in the court of law.

On February 4th, the Glendo Volunteer Rural Fire Department members met for their annual Fire Safety Meeting. Twenty-two members were in attendance along with the new Emergency Manager, Tony Krotz, newly appointed Charlie 1, Mark Walker, and Charlie 2, Kenny Small.

Krotz opened up with introductions, the expectations of his position, and how he will help Walker and Small when fires arise. Walker will be our area director for the East side of the interstate and Small will be on the West side of the interstate. Both men are here to support the incident commander when a fire presents itself and not to take over.

Small went into fire training and showed a video of a small rural Utah Fire Department, comparable to our area. Because of a lack of communication and the wind that day, that department got themselves backed into a corner and had to drive through the fire to get to the black to save themselves. Two of those firemen sustained 2-3 degree burns and were lucky to survive that fire. Small stated, "Anyone that shows up to a fire without the proper PPE (personal protective equipment) attire will be sent home." Wearing proper PPE attire is for safety, and anyone who works in a fire needs to wear it.




